

SEARCHING JACKSON COUNTY LAND RECORDS ONLINE


STEP 1:

To begin the search process click on **Jackson County Land Records Portal**.




STEP 2:

A new window should open. You have now reached <http://landrecords.co.jackson.ms.us>, Click where it says [Click here to acknowledge the disclaimer and enter the site.](#)




STEP 3:

Disregard the message in red and do not worry about logging in unless you have an Escrow Account. Those without an Escrow can search without being logged in. You are looking for [Real Estate](#) between Welcome and FAQ in the upper left hand corner, place mouse over [Real Estate](#), another box should pop up that says [Search Real Estate Index](#), Click [Search Real Estate Index](#).



STEP 4:

Once you click on Search Real Estate Index it will take you to the Search Page where you can put in whatever information you have and click Search at the top or the bottom.



STEP 5:

Once you hit Search it will bring up any and all documents that sight the information you provided. If the document was recorded between July 29th 2002 to present, you will have the option to view by clicking [View](#) below Image, Any documents recorded before that date will not have the option to view but you can still see Information in other categories, book and page number, the Grantor and Grantee, Legal description, and any of the book and page numbers for cross referenced documents, click the instrument #/ Book-Page to view more. Also, an [R] is for Grantor and [E] is for Grantee.
